ORDINANCE NO. 17-38 BY: Earl Williams

Amending Sections 141.18, 141.20, and 141.22 of the Administrative Code of the Shaker Heights Codified Ordinances relative to including non-resident employees of Shaker Heights businesses in the definition of "residents" for the purpose of Recreation Department program fees.

WHEREAS, Section 141.18 was most recently amended in Ordinance No. 16-90, enacted on August 16, 2016; and

WHEREAS, Section 141.20 was most recently amended in Ordinance No. 06-120, enacted on November 27, 2006; and

WHEREAS, Section 141.22 was most recently amended in Ordinance No. 16-46, enacted on April 25, 2016; and

WHEREAS, this Council has determined to allow non-resident employees of Shaker Heights businesses to be considered as "residents" for the purpose of charging fees for various Recreation Department programs.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Shaker Heights, State of Ohio:

 $\underline{\text{Section 1.}}$ Sections 141.18, 141.20, and 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights as heretofore in effect are hereby repealed.

Section 2. Section 141.18, 141.20, and 141.22 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights are hereby enacted as amended as follows:

141.18 THORNTON PARK SWIMMING POOL FEES.

(a) The daily admission fees for the use of Thornton Park swimming pool for residents, including residents of the City and School District, and non-resident guests, who must accompany a resident to be admitted, shall be:

The Short-Term Guest Pass must be purchased by the resident. Any employee of a business located in Shaker Heights who works at the Shaker Heights location shall be considered a "resident" for the purpose of this sub-Section. The Director of Recreation may establish rules for determining eligibility for the Short-Term (5-day) Pool Pass.

141.20 OUTDOOR SKATE PARK AND BASKETBALL COURT PHOTO IDENTIFICATION CARD FEE.

A fee of five dollar (\$5.00) for a photo identification card will be charged per season per resident for use of the outdoor skate park and the outdoor basketball court at Thornton Park. Payment of the fee and issuance of the identification card will enable a resident to use both facilities. Any employee of a business located in Shaker Heights who works at the Shaker Heights location shall be considered a "resident" for the purpose of this sub-Section.
