Now, therefore, if said \_\_\_\_\_ shall well and truly indemnify, keep and save harmless the City of Shaker Heights from all loss and damages that may be occasioned in any way by accident, or by the want of care, skill or attention on his part or on the part of any one in his employ in the prosecution, protection or completion of such work, or that may be occasioned by reason of any opening made or caused to be made by him in any street or public ground for the doing of any work therein, or by reason of the placing of any material in any such street or public ground; and if he will promptly at the proper time, replace and restore or cause to be replaced or restored the street and pavement or other public property over such opening to as good a state and condition as he found it previous to opening the same, or pay the City for having the same replaced or restored, as the City may elect; and if he will conform in all respects to the ordinances, rules and regulations which may, from time to time, be established by said City; and if he shall save the City harmless from all loss or damages that may in any way be occasioned by reason of such opening in any street or public ground at any time until said opening shall have been permanently repaired, then this obligation shall be void - otherwise it shall be and remain in full force and virtue.
