

ORDINANCE NO. 16-90

Amending Section 141.18 of the Administrative Code of the Shaker Heights Codified Ordinances relative to Thornton Park Swimming Pool fees for non-residents.

WHEREAS, Section 141.18 was most recently amended in Ordinance No. 15-86, enacted on October 26, 2015; and

WHEREAS, this Council has determined to allow non-resident guests to be at the pool unaccompanied by a resident if they are a relative visiting from a distance of 50 miles or more.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Shaker Heights, State of Ohio:

Section 1. Section 141.18 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights as heretofore in effect is hereby repealed.

Section 2. Section 141.18 of the Administrative Code of the Codified Ordinances of the City of Shaker Heights is hereby enacted as amended as follows:

141.18 THORNTON PARK SWIMMING POOL FEES.

(a) The daily admission fees for the use of Thornton Park swimming pool for residents, including residents of the City and School District, and non resident guests, who must accompany a resident to be admitted, shall be:

Preschool (Ages 2-4)	\$2.00	\$3.50
Youth (Ages 5-18)	\$5.00	\$8.50
Adult (Ages 19-49)	\$6.00	\$9.00
Adult (50+)	\$5.00	\$8.50
Spectator (Non-Swimming)	\$5.00	\$8.50.

The Director of Recreation may establish rules for the use of Thornton Park Pool by non-residents.

(b) The pool pass fees for the use of Thornton Park swimming pool by residents, including residents of the City and School District, and non-residents shall be:

<u>Resident</u>	<u>Early Bird</u>	<u>Pre- Season</u>	<u>Regular</u>
Individual (Ages 5-49)	\$70	\$95	\$115
Each Additional	\$30	\$30	\$35
Family Maximum (6)	\$220	\$245	\$290
Individual (50+)	\$45	\$60	\$70
Husband/Wife (50+)	\$60	\$80	\$95
Partial Swim (15 Swims)	\$70	\$70	\$70

<u>Non-Resident</u>			
Individual (Ages 5-49)			\$175
Each Additional			\$50
Family Maximum (6)			\$425
Individual (50+)			\$105
Husband/Wife (50+)			\$145
Partial Swim (15 Swims)	\$100	\$100	\$100.

The Director of Recreation may establish rules for the use of Thornton Park Pool by non-residents.

(c) The pool rental fees for the use of Thornton Park swimming pool shall be:

<u>Number of Guests</u>	<u>Fees</u>
1-100	\$150
Each Additional 100	\$50.

(d) The Nanny Pool Pass fees for the use of Thornton Park swimming pool shall be:

Early Bird Rate	\$75
Pre-Season Rate	\$100
Regular Rate	\$120.

The Director of Recreation may establish rules for determining eligibility for the Nanny Pool Pass rate.

(e) The Short-Term (5-day) Pool Pass for the use of the Thornton Park Swimming Pool for non-resident guests (who are related to the resident and live more than 50 miles from Thornton Park) shall be:

<u>Preschool</u>	<u>\$17.50</u>
<u>Youth</u>	<u>\$42.50</u>
<u>Adult</u>	<u>\$45.00</u>
<u>Senior</u>	<u>\$42.50.</u>

The Short-Term Guest Pass must be purchased by the resident. The Director of Recreation may establish rules for determining eligibility for the Short-Term (5-day) Pool Pass.

Section 3. This ordinance shall take effect from and after the earliest time allowed by law.
