Approval of the March 10, 2022 Meeting Minutes

It was moved by Anne Williams and seconded by Sean Malone that the minutes of the March 10, 2022 meeting be approved as recorded; unanimously passed.

Holden Forests & Gardens – Trees for People Program

Our guest speaker was not able to join the call, but sent two documents for distribution (both are attached to the online agenda) regarding the Trees for People program. This initiative of Holden Forests & Gardens, which includes the Holden Arboretum and Cleveland Botanical Garden, has a goal of planting 15,000 trees by 2025.

To achieve this goal, the Trees for People program includes a pledge made by a home owner, institution, or business to plant one or more trees. Once this pledge is made, online at holdenfg.org/trees-for-people, the pledger will receive access to multiple resources for successfully selecting, planting, and caring for a young tree. This includes a tree selection guide, tree care toolkit, and emails outlining resources available.

Holden has also identified ways to make taking the pledge as accessible as possible, by promoting events where free tree seedlings are available (the next one is for Arbor Day at Holden’s facilities), using free wood chips available from the City (near Lower Lake at Larchmere and South Park Boulevards), and using compost (available from Rust Belt Riders or made in the back yard – please get your permit).

Council Member Nancy Moore added that the City’s Tree Advisory Board can also assist residents with tree selection and identifying native species. She also noted that for front yard planting in particular to call OUPS for a free identification of all utility lines in the yard so the tree is not planted above a utility line that may cause issues in the future. In addition to the free wood chips, those planting trees should also provide deer protection by using wire mesh and ideally staking the tree.

Holden has also been supportive of the City’s efforts, with Amanda Woods suggesting appropriate trees for the Grow Not Mow site at South Park Boulevard and Lee Road.

Upcoming tree events include the planting day at the Grow Not Mow site at South Park and Courtland Boulevards on April 30th (10am to 1pm) and on May 7th from 9am to noon in the Moreland Neighborhood with Boise and the Arbor Day Foundation to fill in gaps in the tree canopy by planting 24 trees on treelawns.

Subcommittee Updates

Stormwater & Greenspace (Julia Larouche)

- The Subcommittee requested information from the City and Schools about pesticide use; it is in the process of drafting a policy statement regarding disclosure
- Grow Not Mow – Site 1 (Courtland and South Park Blvds) will have a community planting day on April 30th from 10am until 1pm; grants have been pursued for Site 2 (Lee Road and South Park Blvd) for future planning. Sites 3 and 4 were presented by
- School District sustainability efforts were discussed, including the current RFP for a food service vendor and the inclusion of language regarding diverting food waste. While individual schools with support of their PTOs have been a focus of expanding food diversion strategies, a District-level approach is also important.
 - Nancy Moore suggested Julia Larouche and Michael Peters attend the Onaway Association meeting on April 24th.
 - Onaway is discussing a program for the next academic year with Rust Belt Riders and will have an Earth Day composting event this year.
 - Sean Malone asked about recycling in the Schools, which reportedly has stopped at least at the Middle School. Jeff Isaacs said he would inquire.
 - Norman Robbins asked about integrating these concepts into the education plan; Jeff Isaacs indicated they were part of the curriculum at the elementary school level and likely even more widely; he will also report back on this.

- Nancy Moore discussed how the approach is like a 4-legged stool requiring the participation and cooperation of the Schools, PTOs, City, and community organizations.

Renewable Energy (Norman Robbins)

- A subcommittee member reported that at a recent Architectural Board of Review meeting there were five applications for rooftop solar.
- There will be a meeting on June 9th at Nature’s Oasis on the solar co-op.
- Dominion Energy is offering a home energy audit, free to Shaker Heights residents if they mention they are a resident when making the appointment; continuing to look into providing residents with a rebate if they elect to install a smart programmable thermostat that is projected to result in savings of 10 to 15 percent.
- Michael Peters gave an update of the Community Choice Aggregation process – four responses were received to the RFP for a consultant, all were deemed to be of high quality. A City Council work session next week will provide a further update.
- Nancy Moore discussed the C-PACE or Commercial Property-Assessed Clean Energy program that a Shaker Heights business is using to increase the energy efficiency of a building. This was arranged with the assistance of the City’s Economic Development Department. The City’s membership in the Northeast Ohio Advanced Energy District allows for C-PACE financing in the City, which is collected through the real estate tax bill.
- David Pogue’s recent talk at the Shaker Heights Public Library was mentioned along with a question about planning for climate change at the City level. Michael Peters responded that much of this longer-range planning was being done at the Cuyahoga County level, including work with the University of Buffalo.

Shaker Youth LEEDs / High School Advisory Group (presented by Michael Peters)

- EcoChallenge started April 1st – everyone is encouraged to sign up

Discussion of Hybrid Versus In Person Meetings

The Committee was asked to weigh in on whether it would prefer to continue to have virtual meetings, return to in-person meetings, or take a hybrid approach. Several members commented on their preference for the flexibility virtual meetings offered and the resulting high attendance. It was decided to continue to primarily meet virtually with periodic in-person meetings for brainstorming and networking.

Should a future meeting be held in a hybrid format, it was also decided that a Committee Member joining electronically could vote and be counted towards quorum.

For virtual meetings, it was also decided that while being visible on video was preferred, if a Committee Member was not able to be on video the vote would be valid.

Re: **Electric Vehicle Infrastructure / Shaker Plaza**

The City has been requested by Tesla to host a Supercharger electric vehicle charging location in the City-owned parking lot at Shaker Plaza. The site is the lower level parking lot adjacent to the shopping center and the RTA Blue Line rapid terminal. This Supercharger location would host 12 charging stations, which is reported by Tesla to be their standard configuration.

The addition of this infrastructure is consistent with the City's electric vehicle charging and overall sustainability initiatives. It is complementary to the electric vehicle charging stations installed by the City and in the nearby Van Aken District parking garage and in aggregate remains a small fraction of the overall public charging facilities that will be required as electric vehicle (EV) adoption continues to grow exponentially.

This location will establish the Van Aken District as a regional electric vehicle charging hub and is expected to benefit the City and its residents and businesses. A Supercharger location, which to date is rarely found away from an interstate highway, will be an attraction for EV drivers who will then likely patronize the local businesses in Shaker Plaza and the Van Aken District. This location will appear in all Tesla vehicles in the navigation system as a charging location and draw drivers to the area.

The much faster charging speeds of these chargers will also allow residents who live in multi-family housing and may not have access to charging to also realize the benefits of driving an EV (including much lower operating and maintenance costs).

Currently the Superchargers are limited to charging Tesla vehicles; however, Tesla has committed to opening the charging network to additional EVs and is piloting such a program in Europe currently. Tesla representatives have indicated that this location would similarly be opened to other EVs as the program is expanded to the U.S. (however no firm timeline has been announced). Additional DC Fast Chargers, similar in capacity to the Superchargers, are also scheduled to be installed through a NOACA program on Tuttle Road later this year. These will be compatible with nearly all EVs and mitigates the concerns over the initial limited availability of the Superchargers.

According to the Drive Ohio / ODOT database, as of January 2022 there are 98 battery electric vehicles registered in Shaker Heights. Of those, 68 are Tesla models, or 69%.

Tesla is requesting a license to install the 12 Superchargers and accompanying equipment in the City-owned parking area and it will be responsible for all costs associated with installing and operating the Superchargers. The agreement is being finalized but anticipates a 5-year initial term with two 5-year renewals. There is a relocation provision. The City would receive no revenues or direct payments. In contrast, the two DC Fast Chargers being installed by NOACA will be installed by NOACA but the City will assume operational responsibility, including the electric service. For the 2023 budget, \$12,000 is being projected for net costs to the City for operating the chargers.

The Sustainability Committee is requested to recommend to City Council that it authorize the Mayor to enter into the license agreement, once finalized, with Tesla for the construction and operation of the Shaker Heights Supercharger location. The Finance Committee will also review this matter prior to discussion by City Council.
